4. I agree that in the event of cancellation of the Event due to storm, rain, inclement weather, winds or other 'Act of God' conditions or safety concerns, or if I do not participate in the event for any other reason, my entry fee shall be non-refundable.
5. I agree that registration applications are non-transferable.
6. I consent to the free use of my name, personal information, photograph, interview or appearance in any newspaper, promotion, advertising material, publication, video, broadcast, website or use in any media now known or yet to be devised, by Albury Wodonga Mountain Bikers, Victorian Enduro Series, and/or its sponsors.
